Scripts and Music Scores are strictly copyright and must not be photocopied or reproduced in any way.

Postage (including overseas) is charged at cost (see purchase order form).
Videotaping/DVD recording of live performances is now free.

All **Product Charges and Royalty Fees** are listed.

Once you have decided what show you would like to perform, and you have completed the **Purchase Order Form**, you must then complete the **Performing Licence Application Form** and ensure that you have given yourself plenty of time for the Performing Licence to arrive before you begin rehearsals.

A Performing Licence must be obtained before any rehearsals/performances can be given.

Failure to do so is an infringement of International Copyright Laws.

Where cancellation is unavoidable, the Producing Organisation must inform Vallier Music in writing. Vallier Music reserves the right to charge the Producing Organisation a fee for the cancellation (by way of Liquidated Damages and not as a penalty).

Where cancellations are received in advance of 14 days of the first licensed performance, the charge will be 20% of the total royalty fees paid. The difference will be refunded.

Where advice of cancellation is received within 14 days of the first licensed performance, all advance monies paid as royalty fees will be forfeited

For scripts, scores and CDs, payment should accompany the customer's **Purchase Order Form**.

For Royalties, the stated or quoted royalty fees are payable at the time of applying for a performing licence and should accompany the customer's **Performing Licence Application Form**.

The Performing Licence Application Form does not constitute a licence to perform. A licence will be issued separately confirming all performance details as requested.
